Data collection began in March 2017 via the State Fairgrounds Area Neighborhoods Survey (SFANS), an original tool developed by the PI in collaboration with community partners in Detroit; qualitative data are being gathered through targeted (invited) and open call focus groups, individual interviews, participatory community mapping, and participant observations of the field team.
